You have changed your mind at least three times, that you would allow my representative to come or you would not. yesterday, you definitively said you would not allow him to come. Your emotional ups and downs cause a lot of problems.

The deadline passed to buy airplane tickets for early next week. I can check, but I think its best to buy the tickets for Monday May 15<sup>th</sup>. he will plan on being there several days.

Let me know if this is agreeable. If I don't hear from you I will assume its not acceptable.

From Johan (via text, copied here)

I fully understand your reaction from yesterday. You really believe that you have been emailing with me in the past 1,5 weeks and I can't blame you. Mails seem to come from my account and look optically OK.

I can't make you believe in me if you choose otherwise. But we've communicated for months, so you know my style. Compare it to the mails you've received from 15th April onwards. I'm sure you will notice differences. Brian was here and knows me in person and what I'm like.

I've spent 3 hours with IT specialists from GoDaddy (my email provider) yesterday and today. We know how the hacker operated and can prove that the mails you sent in the past 1,5 weeks were never delivered to my inbox. We've made several security updates. Hopefully the hacker will no longer be able to send phishing emails from my account or divert incoming post to his sever. We can see from the records that nothing has been sent to you since the security updates were implemented, which is encouraging but still not proof.

It will take 24-48 hours for me to be able to send and receive emails from my account again, as a complete reset was done. After that it should work as before.

I don't know what the hacker has written to you, but I feared the worst and that is why I reached out to Jennifer from my private email. What would I have to gain from doing that unless I was desperate and worried and wanted to warn you?

The only other secure medium is our iPhone group. A hacker can get into my emails but can't infiltrate this group. Please consult your IT guys.

Repeating myself: if you want to send someone to Budapest, do so! I would never turn down an offer like that. Again, ask yourself by comparing to all our previous arrangements and how I've reacted and communicated in the past.

If you want me to make another video with the cars in the garage with a newspaper of the day, I'm happy to do so. Or any other proof that I'm the real Johan (it's absurd to even have to write it). Perhaps involving the AirTags, that Brian got for the cars? Open to anything.

Hi Brian,

On Monday I sent you and your Dad a video of your cars in the garage. Have you watched it yet? Please do, as it's crucial that you understand what has been going on with the attempted fraud and what the current status of the cars is.

As I wrote, my email has been recovered and should now be clean, safe and out of reach from the fraudsters, that were emailing with your Dad from around 15<sup>th</sup> April to 3<sup>rd</sup> May.

To prove that it's actually Johan you're communicating with now and not the fraudsters, here a couple of facts, that only you and I can possibly know (apart from the video):

1. Attached a photo of the cool shirt you brought me from the US
2. You enquired about the Volkswagen powered water pump, that is also in the garage with the cars
3. I took you to 'Ket Szerecsen' for dinner, where we shared a starter platter with cold cuts. You had no more food, while I had a duck main course. You drank some pints of local lager, Tammy an ice tea
4. Starbucks in the Castle District messed up our order. Instead of the Frappuccino we asked for, they gave us normal Cappuccino

We have now done everything we can and we can proceed from here only once the funds have arrived. Next step is to order containers.

If the funds arrive tomorrow, the cars can most probably be shipped before 20th and arrive FL 6 weeks later.





Hi Ron and Brian,

Thank you for your patience and trust. Good news, as we've finally tackled the bureaucratic issues and will get all documentation we need, both on our side for export and on your side for customs and DMV.

I'm updating the Vehicle Sales Agreements and will have them signed by Janos (the current owner) tomorrow. Thereafter I'll send them to you for signature.

Apologies for the delay. All that matters is that we have solved the issues. You can stop reading here if you like. However, you may wonder what has taken so long, and rightfully so. Thus, I list below what the owner and myself went through in the past two weeks. Please don't get intimidated or worried, it's just a terrible example of bureaucracy and how authorities can make life difficult rather than easy for its citizens.

As you know, Janos inherited the cars from his father. He has an official document showing this and that he is the rightful owner. As he decided to sell the cars and thus had no intention of registering them for road use in Hungary under his name, they were temporarily deregistered and the vehicle documents still in his father's name. Now the problems start. Janos went to the authority (local DMV) to announce that the cars are sold and will be exported from Hungary. At first, he was told: no problem, you don't need to transfer the titles to your name. The local DMV will keep the license plates and the old titles when deregistering the vehicles and you will receive an official document stating this. So far, so good, we thought. Janos made notarized copies of the old vehicle documents, which we were going to have officially translated into English. With these documents, we went to the meeting I organised with the shipper and the export agent last Friday. However, the latter told us, that this is not enough, he needs the invalidated original Hungarian titles in paper form to be able to export the vehicles to a third country (outside of the European Union). Notarized copies of the old documents are not sufficient for him. Two government agencies, each not knowing how the other operates. So, back to the DMV. Since we need invalidated titles in paper form for export, and the old titles in his father's name would be kept by the DMV, the titles need to be transferred to Janos' name. Should be no problem, as he is the rightful owner, and isn't in any other country I know of. However, because of how the Hungarian DMV IT system is programmed, new vehicle documents can only be issued and printed out, once the car has a new, valid technical test for road use. No catering for someone not wishing to use his car on Hungarian roads for whatever reason: export, collections, museums etc. or simply someone wishing to put his possession in his living room. Seriously, you couldn't make this up! Janos was told that there is no way around it. If he wants to transfer the titles to his name, he needs to have the cars officially examined, as if they were going to be road registered in Hungary. Now, this is not an issue because of the condition of the cars, as they are excellent. However, since they have a special classic car registration, they can only be re-registered as such. And

that is a two-step process, with first a regular test station going through the vehicles and then a special examination by the Hungarian Classic Car Club, that issues the necessary documents for the DMV. You may need to wait months for a date with the latter. And all of this for cars, that are going to be exported and never driven again in Hungarian traffic. Hilarious and sad at the same time with no logic whatsoever. Hungarian bureaucracy at its worst. The DMV doesn't care, as they can't see beyond their own desk, even though the issue is with their IT system. We escalated the issue to DMV management, who were of no help.

However, we managed to contact the Chairman of The Hungarian Classic Car Club, who immediately understood the problem. He promised to issue renewed classic car documents in Janos' name without the need to go through the testing procedure. With these, we can then get the titles transferred to Janos' name by the DMV and we will get the invalidated originals as required for export and are good to go. This may take a week, but will get done.

On another note, we might even be able to retrieve the original US Titles from the DMV but I can't promise this. Janos found out, that his father had successfully challenged the rule, that the DMV always keep the original foreign titles when a car is imported and registered in Hungary. He had to go through two instances, but was at the end given right, stating that a notarized copy should be enough for the DMV. Now, you won't need original US Titles, as you'll have the Hungarian ones, but it would certainly make things easier on your side. We'll give it a go. If it works, it works, and would be an added bonus.

If anything needs to be changed and/or amended, we'll address that immediately. Call me overly cautious, but I'd rather invest a couple of days now to ensure all is clear, rather than potentially facing problems here or in the US later. I informed Brian about this yesterday.

Attached, please find draft BoS. One set of normal agreements and one set with purchase prices adjusted for US import duties, as agreed. The latter have a '(1)' after the file name. Otherwise identical. Under 'Scope' I mention that we will finalise the list of documents after our Friday meeting mentioned above. We'll sign them once this is done. Last but not least BoS for bonded titles. Might be worth checking with Ms. Hill if they are OK like this

and whether a foreigner can be the seller in this case?

Purchase prices add up to €284k, which is the book value of the cars for local taxes. I agreed with Brian, that we put the remaining €6k on a separate invoice, that also includes shipping, import, customs etc. as a consulting fee.

I also include the seller's ID as well as my own, as I already received Ron's from Brian.

As the owner is a former Director of Sony Pictures, he took all main Hollywood stars for a ride on the red carpet in his car during the Berlin Film Festivals 😊

The 1951 Standard EU Title was included. I attach it here again, so that you don't have to search. It's attractively priced at €36,000. Remember, the Standards were never sold outside of Germany and some other EU markets and never exported to the US. Great testimony to the need for affordable mobility after WWII. If you watch my YouTube video, you'll see the huge contrast to the 1952 Export model from my native Sweden. I've only found one Standard car in the US restored to original spec. (correct ones are hard to find in Europe as well):
